Co-evaluation between ST & OT	Only for feeding cases requiring both Speech and OT	\$1200.00
Re-Evaluation - OT, PT, ST	Completed annually on clients with current plan of care to readjust baselines, goals, and medical necessity	\$500.00
Clinic Session - OT, PT, ST	60 minutes	\$180.00

OT/PT Aquatic Therapy	60 minutes	\$200.00
Adapted Equipment Evaluation	An evaluation done mid plan of care for adapted equipment such as an AAC device or orthotics	\$500.00
Cotreatment between PT & ST	60-minute session made of up of 60 minutes of PT, with a 30 min overlap of ST; must be recommended by therapists	\$240.00
Cotreatment between OT & ST	60-minute session made of up of 60 minutes of OT, with a 30 min overlap of ST; must be recommended by therapists	\$240.00
Cotreatment between PT & OT	60 minutes of combined OT and PT; must be recommended by therapists	\$310.00
Consultation and/or Caregiver Training	Phone consults/meeting > 15 min with clinical staff, initiated by client	\$180.00/hr

Off Site Observation or Treatment Session - OT, PT, ST	Performed only under special circumstances, time includes travel time. Will be billed as either 1 hr (up to 60 minutes) or 2 hours (60-120 minutes).	\$190.00/hr
Clinic-Based Group	Minimum of 2 children ("dyad"), 60 minutes For 3 or more children, 60 minutes	\$125.00/child \$100.00/child
Developmental Screening	Initial screening to see if evaluation is warranted	\$50.00
Easy Rider Session	Bike Riding Lesson	\$130.00
Adapted Swim Lesson	Adapted Swim Lesson with goal to learn to swim	\$80.00
Late Cancel/No Show Fee	No show, <24 hr notice cancel, no call for sick	\$110.00
Late Arrival Fee	Late arrival ≥8 minutes, for every 15 minutes late.	\$30.00
Late Pick Up Fee	Late pick up of >10 minutes past session time	\$30.00
Administrative Fee	To send medical records outside of insurance request	\$20.00
